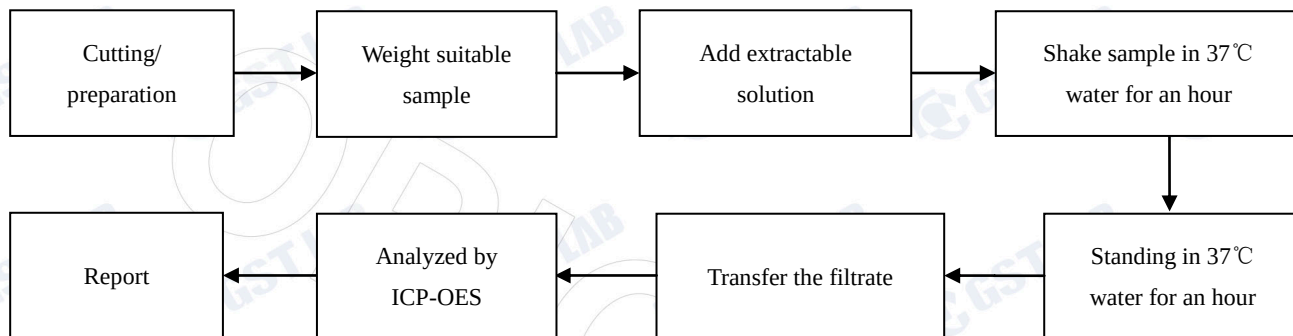

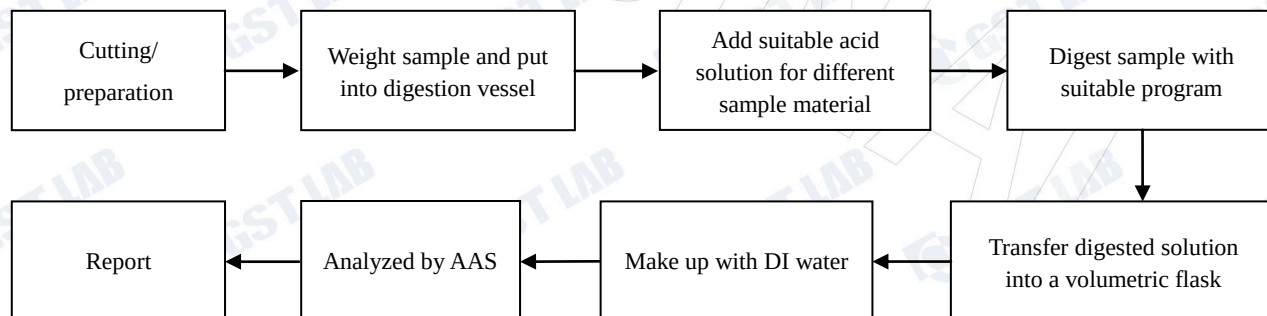

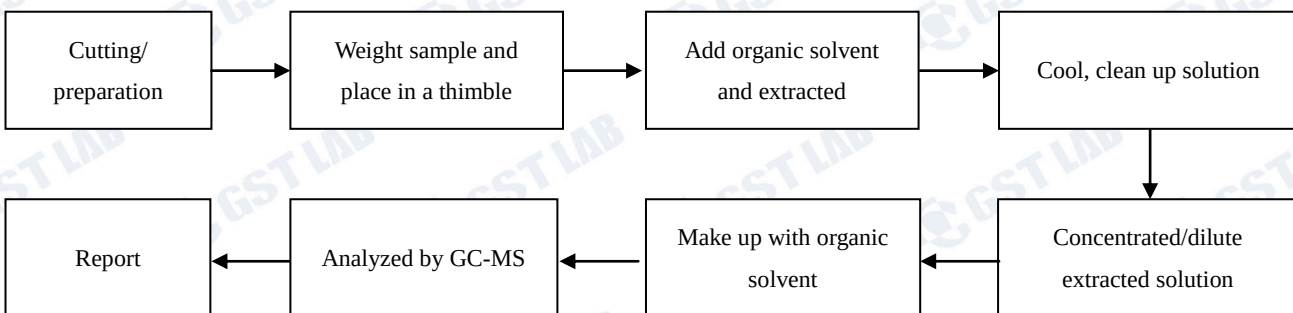
1. Test flowchart for soluble elements content:
